






















Land Use Zone Map

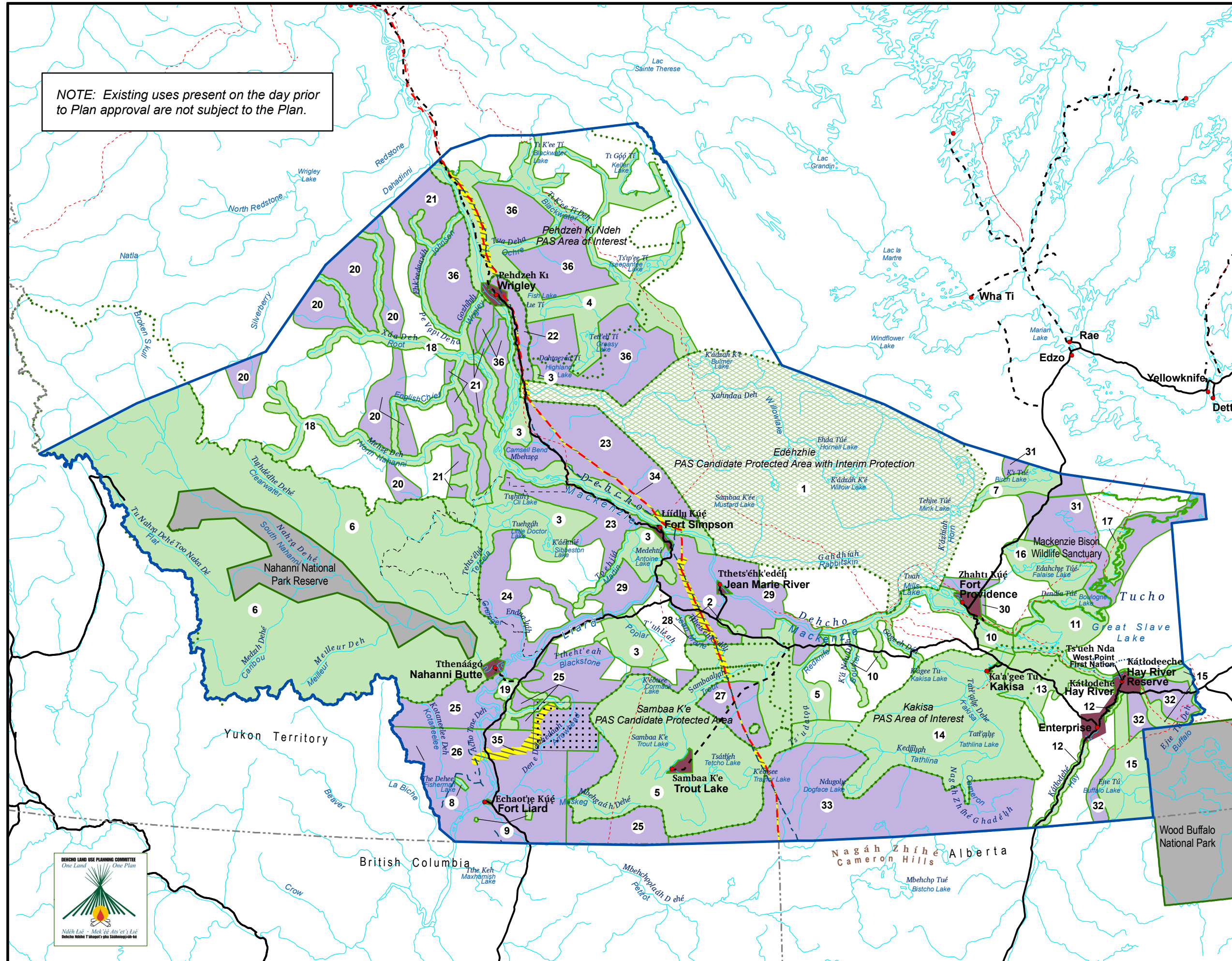
